Greetings to you from the training staff of IP3! We welcome you to our online course for what will be an exciting and engaging program.

24 hours prior to the start date of the course (which is usually on a Wednesday), IP3 will be emailing you the following information:

1. A link, username, and password that you can use to log in to the course site (www.coursesites.com)
2. An attached document in PDF titled, "Navigating the Course Site"
3. An attached document in PDF format titled, "Course Syllabus"
4. An attached document in PDF format titled, "IP3 Action Planning Process"

Please make sure you have PDF functionality. If you do not, you can upload a free copy of Adobe Reader at www.adobe.com.

What can you expect?

The course lasts six weeks and consists of 6 modules. Each module has a series of assignments that must be completed over a one-week period of time and with specific deadlines. The weekly assignments include:

- Reviewing topical "content-enriched" documents and case studies and posting responses to questions into a Discussion Board thread;
- Engaging in online group "discussions" and debates with fellow participants on the course content sessions, case studies, and action plan development;
- Developing, through a six-step process, a comprehensive strategic action plan for yourself; and
- Engaging in direct communications and receiving personal and professional feedback from our "Course Facilitator" and special guest commentators on your work progress.

You will be graded on a "pass-fail" format based on accurate and timely completion of assignments, level of participation in the discussion board communications, and the content/structure of your action plan. Successful completion of the course will earn you 3.0 continuing education units (CEUs). We estimate that the assignments will take approximately 5 hours per week. You can complete your assignments whenever you want during each one-week period, however, be mindful of each set of deadlines for submitting your assignments.
